I agree to indemnify and hold harmless the Publisher, its affiliates and its and their respective shareholders, directors, officers, employees, agents and assigns from any and all claims, suits, or liabilities, including any damages, attorney’s fees, and costs arising out of (1) the breach of the representations made in the prior paragraph; or (2) an allegation that the Work infringes the rights of any third party.
