History of Pregnancy Cuts Unprovoked VTE Risk

ORLANDO, FLA. — Having a child cuts the risk of unprovoked venous thromboembolism, according to an epidemiologic study with more than 19,000 women.

Compared with women who were never pregnant, women with a history of at least one pregnancy had a 41% reduced risk of venous thromboembolism (VTE) in a multivariate model that was adjusted for several potential confounders, Christiana Iyasere, M.D., said at the annual meeting of the American College of Cardiology.

The difference in risk was statistically significant, said Dr. Iyasere, a cardiologist at Brigham and Women's Hospital in Boston.

The overall incidence of unprovoked VTE in nulliparous women was about 0.8%, compared with a rate of about 0.5% in women who had at least one pregnancy. This means that, on average, a history of pregnancy cut the population risk for

unprovoked VTE by about 3 cases per 1,000 people.

The study used data collected in the Women's Health Study, which recruited postmenopausal women in the health professions with a primary goal of assessing the safety and efficacy of aspirin and vitamin E for the primary prevention of cardiovascular disease. Dr. Iyasere and her associates used data collected by questionnaire from the nearly 40,000 women in this study to evaluate the impact of endogenous hormones on VTE risk.

They excluded women with a history of VTE, known hypercoagulable states, a history of prolonged immobility, a history of malignancy, or recent trauma. The analyses were done using data collected from the remaining 19,219 women.

The researchers found no detectable association between VTE risk and age of menarche, age of menopause, and total duration of menses. There was also no significant association between VTE risk and parity when the women were subdivided into four categories based on their childbearing history: nulliparous, one or two pregnancies, three or four pregnancies, or five or more pregnancies. But a statistically significant association existed when the comparison was made between nulliparous women and those with any pregnancy.

Among 2,635 nulliparous women, 21 reported having an unprovoked VTE. Among 16,584 women who were pregnant at least once, 86 had an unprovoked VTE.

The fully adjusted multivariate model corrected the hazard ratio for age, history of exogenous hormone use, body mass index, history of diabetes or hypertension, history of smoking, and exercise activity.

The researchers were surprised to find no apparent link between other measures of endogenous hormone exposure and VTE risk because exogenous hormones, in the form of oral contraceptives and hormone therapy, are proven risk factors for an increased VTE incidence, Dr. Iyasere said.

INDICATIONS AND USAGE
LUNESTA is indicated for the treatment of insomnia. In controlled outpatient and sleep laboratory studies, LUNESTA administered at bedtime decreased sleep latency and improved sleep maintenance.

WARNINGS

Because sleep disturbances may be the presenting manifestation of a physical and/or psychiatric disorder, symptomatic treatment of insomnia should be initiated only after a careful evaluation of the patient. The failure of insomnia to remit after 7 to 10 days of treatment may indicate the presence of a primary psychiatric and/or medical lineas that should be evaluated. A variety of abnormal thinking and behavior changes have been reported to occur in association with the use of sedative/hypnotics. Some of these changes may be characterized by decreased inhibition (e.g., aggressiveness and extroversion that seem out of character), similar to effects produced by alcohol and other CNS depressants. Other reported behavioral changes have included bizarre behavior, agitation, hallucinations, and depersonalization. Annesse and other neuropsychiatric symptoms may occur unpredictably. In primarily depressed patients, worsening of depression, including suicidal thinking, has been reported in association with the use of sedative/hypnotics.

It can rarely be determined with certainty whether a particular instance of the abnormal behaviors listed above are drug-induced, spontaneous in origin, or a result of an underlying psychiatric or physical disorder. Following rapid dose decrease or abruft discontinuation of the use of sedative/hyp-notics, there have been reports of signs and symptoms similar to those associated with withdrawal from other CNS-depressant drugs (see DRUG ABUSE AND DEPPENDENCE). LUNESTA, like other hypnotics, has CNS-depressant effects. Because of the rapid onset of action, LUNESTA should not be ingested immediately prior to going to be or after the patient has gone to bed and has experienced difficulty falling asleep. Patients receiving LUNESTA should be cautioned against engaging in hazardous occupations requiring complete mental alemenses or motor coordination (e.g., operating machinery or driving a motor vehicle) after ingesting the drug, and be cautioned about potential impairment of the performance of such activities on the day following ingestion of LUNESTA. LUNESTA, like other hypnotics, may produce additive CNS-depressant effects when coadministered with other psychotropic medications, anticonvulsants, antihistamines, chanol, and other drugs that themselves produce CNS depression. LUNESTA should not be taken with alcohol. Dose adjustment may be necessary when LUNESTA is a diministered with other CNS-depressant agents, because of the potentially additive effects.

A study in healthy volunteers did not reveal respiratory-depressant effects at doses 2.5-fold higher (7 mg) than the recommended dose of excepcione. Caution is advised, however, if LUNESTA is prescribed to patients with compromised respiratory function. The dose of LUNESTA should be reduced to 1 mg in patients with severe hepatic impairment, because systemic exposure is doubled in such subjects. Laboratory Tests: There are no specific laboratory tests recommended.

Digoxin: A single dose of eszopicione 3 mg did not affect the pharmacokinetics of
digoxin measured at steady state following dosing of 0.5 mg twice daily for one day
and 0.25 mg daily for the next 6 days.

Warfarin: Eszopicione 8 mg administered daily for 5 days did not affect the pharmacokinetics of (R)- or (S)-warfarin, nor were there any changes in the pharmacodynamic profile (prothrombin time) following a single 25-mg oral dose of warfarin.

Carcinogenesis, Mutagenesis, Impairment of Fertility
Carcinogenesis: In a carcinogenicity study in Sprague-Dawley rats in which eszopiclone was given by oral gavage, no increases in tumors were seen; plasma levels
(AUC) of eszopicione at the highest dose used in this study (16 mg/kg/day) are estimated to be 80 (lemates) and 20 (males) times those in humans receiving the maximum recommended human dose (MRHD). However, in a carcinogenicity study in

Sprague-Dawley rats in which racemic zopicione was given in the diet, and in which plasma levels of eszopicione were reached that were greater than those reached in the above study of eszopicione, an increase in mammary gland adenocarionmas in females and an increase in thyroid gland follicular cell adenomas and carcinomas in females were seen at the highest dose of 100 mg/kg/day. Plasma levels of eszopicione at this dose are estimated to be 150 (females) and 70 (males) times those in humans receiving the MRHD. The mechanism for the increase in mammary adenocarcinomas is unknown. The increase in thyroid lumors is thought to be due to increased evels of 154 secondary to increased metabolism of circulating thyroid hormones, a mechanism that is not considered to be relevant to humans.

In a carcinogenicity study in B603F1 mice in which racemic zopicione was given in the diet, an increase in pulmonary carcinomas and carcinomas plus adenomas in females and an increase in skin fibromas and sarcomas in males were seen at the highest dose of 100 mg/kg/day. Plasma levels of eszopicione at this dose are estimated to be 8 (females) and 20 (males) times those in humans receiving the MRHD. The shirt tumors were due to skin lesions induced by aggressive behavior, a mechanism that is not relevant to humans. A carcinogenicity study was also performed in which CD-1 mice were given eszopicione at doses up to 100 mg/kg/day by oral gazage; although this study did not reach a maximum tolerated dose, and was thus inadequate for overal assessment of carcinogenicity groups of the MRHD—i.e., 12 times the exposure in the racemate study.

Mutagenesis: Escopicione was positive in the mouse lymphoma chromosomal aberration assay and produced an equivocal response in the Chinese hamster ovary cell chromosomal aberration assay. It was not mutagenic or clastogenic in the bacterial Arnes gene mutation assay, in an unscheduled DNA synthesis assay, or in an invivo mouse bone marrow micronucleus assay.

(S)-N-desmethyl zopicione, a metabolite of escopicione, was positive in the Chinese hamster ovary cell and human lymphocyte chromosomal aberration assays. It was negative in the bacterial Arnes mutation assay, in an in vitro xP-positabeling DNA adduct assay, and in an in vivo mouse bone marrow chromosomal aberration and micronucleus assay.

Impairment Of Fertifity: Eszopicione was given by oral gavage to male rats at doses up to 45 mgk/gday from 4 weeks premating through mating and to female rats at doses up to 180 mg/kg/day from 2 weeks premating through day 7 of pregnancy. An additional study was performed in which only females were treated, up to 180 mg/kg/day. Eszopicione decreased fertility, probably because of effects in both males and females, with no females becoming pregnant when both males and females were treated with the highest dose; the no-effect dose in both sexes was 5 mg/kg (16 timas the MRHD on a mg/m² basis). Other effects included increased preimplantation loss (no-effect dose 25 mg/kg), and decreases in sperm number and molitility and increases in morphologically abnormal sperm (no-effect dose 5 mg/kg).

In the rat, slight reductions in fetal begin and evidence of developmental delay were seen at maternally toxic doses of 125 and 100 mg/kg/dg, but not at 62.5 mg/kg/dgy (200 times the MRHD on a mg/m² basis). Eszopicione was also administered by oral gavage to pregnant rats throughout the pregnancy and lactation periods at doses of up to 180 mg/kg/dgy, Increased post-implantation loss, decreased postnatal pup weights and survival, and increased postimises the MRHD on a mg/m² basis. These doses did not produce significant maternal toxicity. Eszopicione had no effects on other behavioral measures or reproductive function in the offsprince.

There are no adequate and well-controlled studies of eszopictone in pregnant women.

Eszopictone should be used during pregnancy only if the potential benefit justifies the potential risk to the fetus.

Labor And Delvery: LUNESTA has no established use in labor and delivery.

Nursing Mothers: It is not known whether LUNESTA is excreted in human milk Because many drugs are excreted in human milk, caution should be exercised when LUNESTA is administered to a nursing woman. Pediatric Use: Safety and effectiveness of eszopiclone in children below the age of 18 have not been established.

Gentaritic Use, A Itotal of 287 subjects in double-blind, parallel-group, placebo-controlled clinical trials who received eszopicione were 65 to 86 years of age. The overall pattern of adverse events for elderly subjects (median age = 71 years) in 2-week studies with nighttime dosing of 2 mg eszopicione was not different from that seen in younger adults. LUNESTA2 mg exhibited significant reduction in sleep latency and improvement in sleep martenance in the elderly population.

ADVERSE REACTIONS.

The premarketing development program for LUNESTA included eszopicione exposures in patients and/or normal subjects from two different groups of studies; and approximately 400 normal subjects in clinical pharmacology/pharmacokinetic studies, and approximately 1550 patients in placebo-controlled clinical effectiveness studies, corresponding to approximately 263 patient-exposure years. The conditions and duration of treatment with LUNESTA varied greatly and included (in overlapping categories) open-label and double-blind phases of studies, inpatients and outpatients, and short-term and longer-term exposure. Adverse reactions were assessed by collecting adverse events, results of physical examinations, vital signs, weights, laboratory analyses, and ECGs.

Adverse events during exposure were obtained primarily by general inquiry and recorded by clinical investigators using terminology of their own choosing. Adverse events that suggest a dose-response relationship in elderly adults include pain, dry mouth, and unpleasant taste, with this relationship again clearest for unpleasant taste. These figures cannot be used to predict the incidence of adverse events in the course of usual medical practice because patient characteristics and other factors may differ from those that prevailed in the clinical trials. Similarly, the cited frequencies cannot be compared with figures obtained from other clinical investigations involving different treatments, uses, and investigators.

The cited figures, however, do provide the prescribing physician with some basis for estimating the relative contributions of drug and non-drug factors to the adverse event incidence rate in the population studied.

Other Events Observed During The Premarketing Evaluation Of LUNESTA.

Following is a list of modified COSTART terms that reflect treatment-emergent adverse events as defined in the introduction to the ADVERSE REACTIONS section and reported by approximately 1550 subjects treated with LUNESTA at doses in the range of 1 to 3.5 mg/day during Phase 2 and 3 clinical trials throughout the United States and Canada. All reported events are included except those already instelled elsewhere in labeling, minor events common in the general population, and events unlikely to be drug-related. Although the events reported occurred during treatment with LUNESTA, they were not necessarily caused by it.

DRUG ABUSE AND DEPENDENCE
Controlled Substance Class: LUNESTA is a Schedule IV controlled substance under the Controlled Substances Act. Other substances under the substances and the nonbearcodiazepine hypotolics zalephon and zolpidem. While eszopidone is a hypnotic agent with a chemical structure unrelated to benzodiazepines, it shares some of the pharmacologic properties of the benzodiazepines.

Abuse, Dependence, and Tolerance Abuse and Dependence: in a study of abuse liability conducted in individuals with known histories of benzodiazepine abuse, eszopiclone at doses of 6 and 12 mg pro-duced euphoric effects similar to those of diazepam 20 mg. In this study, at doses 2-fold or greater than the maximum recommended doses, a dose-related increase in reports of amenical and hallucinations was observed for both LUMESTA and diazepam. reports of amnesia and hallucinations was observed for both LUMESTA and diazepam. The clinical trial experience with LUMESTA revealed no evidence of a serious withdrawal syndrome. Nevertheless, the following adverse events included in DSM-IV criteria for uncomplicated sedative/hypnotic withdrawal were reported during clinical table following placebo substitution occurring within 48 hours following the last LUMESTA treatment; anxiety, abnormal dreams, nausea, and upset stomach. These reported adverse events occurred at an incidence of 2% or less. Use of benzodiazepines and similar agents may lead to physical and psychological dependence. The risk of abuse and dependence increases with the dose and during of treatment and concomitant use of other psychoactive drugs. The risk is also greater for patients who have a history of alcohol or drug abuse or history of psychiatric disorders. These patients should be under careful surveillance when receiving LUNESTA or any other hyporotic.

Tolerance: Some loss of efficacy to the hypnotic effect of benzodiazepines and benzo diazepine-like agents may develop after repeated use of these drugs for a few weeks onzepnie-like agents may develop anter repeated use or inseed triggs for a few weeks. No development of follerance to any parameter of sleep measurement was observed over six months. Tolerance to the efficacy of LUNESTA3 mg was assessed by 4-week objective and 6-week subjective measurements of time to sleep onset and sleep main-tenance for LUNESTA in a placebo-controlled 4-day study, and by subjective assess-ments of time to sleep onset and WASO in a placebo-controlled study for 6 months.

OVERDOSAGE
THERE IS Initiated premarketing clinical experience with the effects of an overdosage of LUNESTA. In clinical trials with eszopictone, one case of overdose with up to 36 mg of eszopictone was reported in which the subject fully recovered. Individuals have fully recovered from reacemic zopicione overdoses up to 340 mg (56 times the maximum recommended dose of eszopicione).

Signs And Symptoms. Signs and symptoms of overdose effects of CNS depressants can be expected to present as exaggerations of the pharmacological effects noted in preclinical testing. Impairment of consciousness ranging from somnolence to come has been described. Rare individual instances of Ital outcomes following overdose with racemic zopicione have been reported in Europeen postmarketing reports, most often associated with overdose with other CNS-depressant agents.

Recommended Treatment General symptomatic and supportive measures should be used along with immediate gastric lavage where appropriate. Intravenous fluids should be administered as needed. Flumazenll may be useful. As in all cases of drug overdose, respiration, pulse, blood pressure, and other appropriate signs should be monitored and treated by appropriate medical intervention. The value of dialysis in the treatment of overdosage has not been determined.

Poison Control Center: As with the management of all overdosage, the possibility of outlifely drug ingestion should be considered. The physician may wish to consider contacting a poison control center for up-to-date information on the management of lypnotic drug product overdosage.
